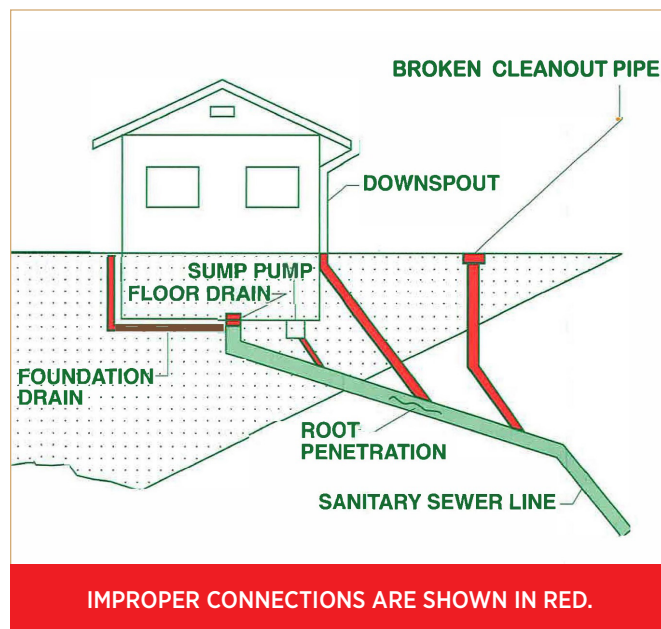

### FREE INSPECTIONS TO REMEDY IMPROPER PUBLIC SEWER HOOK-UPS

It has come to our attention that there is a high volume of stormwater runoff entering the sewer system during rain events. This has resulted in increased costs to the Township, which may lead to increased sewer rental fees in the future. It is possible that your property could be contributing to the problem. We need your help to resolve this issue.



**The following connections to the sewer system contribute to this problem:**

- Downspouts
- Sump pumps
- Basement drains
- Outside area drains
- Broken cleanout pipe (gravity system)

#### **Free Inspection:**

## Board Chairman Letter

### RECENT BOARD OF SUPERVISORS ACTIONS

#### September 2, 2020

- The Declaration of Weather Disaster Emergency executed August 8, 2020 as a result of the Township wide damage caused by Hurricane Isaias August 3 & 4, 2020 was approved.
- The Emergency Road Repair Contract with A.F. Damon, Inc., for the roadway at Old Gradyville Road between the intersections of Creek Road and Slitting Mill Road, as recommended by the Township Engineer and pursuant to the "Declaration of Emergency" was approved.
- The 2020-21 Salt Contract with Eastern Salt Company, Inc., as per the Delaware County Municipalities accepted bid, at \$50.35 per ton was approved.

#### September 16, 2020

- The amended Ballot Box License Agreement with the Delaware County Bureau of Elections in accordance with the revisions required by the Township Solicitor, was approved.
- The Post Office Contracts with Robert Battista for Water Damage, at a cost not to exceed \$5,329.00, the Well Contract with Powell Drilling Services Inc., at a cost not to exceed \$6,180.00, and the Painting Contract with Chris Hauser, at a cost not to exceed \$2,895.00, were approved.

#### October 7, 2020

- The Martin Park Emergency Stormwater Repair contract with Steve Botella Construction & Excavation, Inc., for a total amount not to exceed \$15,780.00, was approved.

The EAC team did both the planning and the heavy lifting of this event, literally, from selecting just the right trees to driving a rented truck to transport the trees then unloading and organizing the trees to create a virtual nursery at the Thornton Farmer's Market Nursery grounds. ### October 7, 2020

- The Emergency Road Repair Contract with A.F. Damon, Inc., in the amount of \$32,400.00, for the roadway at Old Gradyville and Slitting Mill Roads, as recommended by the Township Engineer, was approved.
- The new Guide Rail Installation at the Locksley Road Whistle-stop, in the amount of \$6,000.00, and also a contribution to the West Chester Railroad for structural repairs, in an amount not to exceed \$3,900.00, were approved.

### November 7, 2020

- The proposal from Chris Hauser Painting for the work to be done at the Township Building at a cost not to exceed \$9,975.00, was approved.
- Authorization of Jeff Seagraves to represent Thornbury Township Delaware County, as Voting Delegate at the annual meeting of the Chester County Tax Collection Committee, and approve our portion of the budget which is \$342.17, was approved.

### November 18, 2020

- The extensions on the "Daniels Subdivision," from November 23, 2020, to February 21, 2021, and the "Lawlor Subdivision" from December 3, 2020, to March 3, 2021, were approved.
- Advertising for a Certified Public Accountant or firm, to audit the Township accounts for fiscal year 2020, was approved.

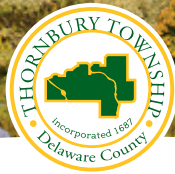

# Historical Commission Letter

## Pay it forward... if these walls could talk

To some, history is a boring subject, to others, it is an interesting story. Vanilla and chocolate. Our town, our area and our historical buildings stood witness to some very significant historic events of our nation's growth and change.

Local organizations such as the Thornbury Historical Society, Colonial Pennsylvania Plantation, Delaware County Historical Society, Chester County History Center, Chris Sanderson Museum, all exist out of respect to you, to promote the remembrance and appreciation of this history because if it is not remembered, it becomes insignificant and lost to future generations. These organizations and thousands more like them are setting the stage for the future.

The program we have in place, of researching the history and the stories of our Township's 204 Historic Resource Properties, albeit five a year, is a thank you our Township extends to the owners and preservers of these assets. The deep meaning of these properties is reflected below in quotes from 19th century writer/social thinker, John Ruskin.

*“The greatest glory of a building is not in its stones, nor in its gold. Its glory is in its Age, and in that deep sense of voicefulness, of stern watching, of mysterious sympathy... which we feel in the walls that have long been washed by the passing waves of humanity.”*

Deep enough for you? The next one is better—and we used it before in our Spring 2011 article.

*“Old buildings are not ours. They belong partly to those who built them and partly to the generations of mankind who are to follow us. The dead still have their right to them. That which they labored for... we have no right to obliterate. What we ourselves have built, we are at liberty to throw down. But what other men gave their strength and wealth and life to accomplish, their right over it does not pass away with their death.”*

In this holiday season when caring and giving is more at the forefront, we encourage you to visit our portion of our Township's website for more information on the organizations listed above as well as the reports and programs we have available for you to review on our history and our resources. ## PLANNING COMMISSION UPDATES

All residents are invited to attend virtual meetings held on the 2nd Wednesday of the month at 7:00pm.

### SUBDIVISION AND LAND DEVELOPMENT

#### 15 Tanguy Rd. (a.k.a. O'Kane) Land Development Sketch Plan

At the July meeting the applicant's engineer proposed tearing down the existing house and constructing a new house, driveway, and pole barn. Tree replacement requirements, pole barn size and accessibility, setbacks, and stormwater were discussed.

The discussion continued at the November meeting. Discussion will continue upon receipt of preliminary or final plans.

#### 74 Locksley Rd. (a.k.a. Anderson/Gregonis) Land Development Plan for a Barn

At the October meeting the applicants proposed replacing a damaged shed/garage and replace it with a 1,576 sq. ft. garage. Stormwater, steep slopes, garage use, impervious area footprint, and tree replacement were discussed. At this meeting the Planning Commission recommended this plan for approval, conditioned

upon compliance with Mr. Ciocco's review letter of October 13, 2020. As part of the motion, the Planning Commission also recommended three of the four waivers.

#### Sleighton School Minor Subdivision Plan

At the October meeting the applicant proposed a plan in which Sleighton School will sell about 80 acres of land to Middletown Twp. to be used for park land.

A sliver of that land is located in Thornbury Township. No development is proposed with

this plan for Middletown Township but discussions are ongoing to develop some land on the east side of Valley Rd. in Edgmont Twp. on about 28 acres that Sleighton School has retained. At this meeting the Planning Commission recommended approval of the plan, conditioned upon compliance with Mr. Ciocco's review letter of October 9, 2020. As part of the motion, the Planning Commission also recommended two waivers, and also recommended that signature blocks need not be required, due to the applicant's request and their clarification on County requirements.





# We Need You!

Due to the ongoing pandemic, we have an **urgent** need for substitute teachers and/or paraprofessionals in the West Chester Area School District. The rate of pay is **\$150/day** for substitute teachers and **\$85/day** for paraprofessionals. You have the flexibility of choosing your own schedule, school building, and position. You can also view available positions at your convenience or have alerts sent to your smart phone for desired positions.



## Who can become a substitute teacher?

Individuals who hold a conferred bachelor's degree and meet all other requirements can receive emergency certification. Individuals who hold a Pennsylvania public educator certificate or a professional-level out-of-state educator certificate and meet all other requirements are eligible to be a substitute teacher.

## What is a Paraprofessional?

A paraprofessional provides instructional, behavioral, and other support to students in and outside of the classroom. Minimum requirements: a high school degree or equivalent, basic computer skills, excellent communication & documentation skills, required clearances.

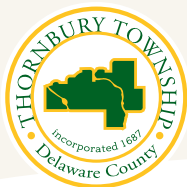
